**2. DELIVERY:** To the street address specified above by Lessee (Customer). Lessee grants Lessor right to enter the property at the said street address ("Delivery Address") for the delivery and subsequent pick up of the Utah Event Rentals unit at the specified time. Transportation expense: Except as provided herein, all charges in delivering and subsequent pick up of the Utah Event Rentals units with respect to the delivery address is included in the rental fee noted above within Salt Lake County only. Any distance beyond SLC county is always subject to additional fees.

\*Delivery NOT included on specified bouncers above.

**3. GENERAL RULES TO FOLLOW DURING USE OF THE UTAH EVENT RENTALS UNIT:**

a. Only compatible age groups and size shall play on the UTAH EVENT RENTALS unit at the same time. The maximum number of riders of each group that should play in the JUMP unit at one time is:

<b>Children 8 &amp; Under</b>	<b>Children 9 To 12</b>	<b>Older Teens</b>	<b>Adults</b>
10	6-8	4-5	4

b. All riders **MUST REMOVE SHOES** before playing in the Bouncer units.

c. To avoid neck and back injuries, **FLIPS ARE NOT ALLOWED**. UTAH EVENT RENTALS OR ANY OF ITS OWNERS OR EMPLOYEES IS **NOT RESPONSIBLE FOR ANY INJURIES THAT OCCUR DURING THE RENTAL PERIOD**. The Lessor is responsible for providing the right supervision of all people using the inflatable units. If an accident by chance occurs the Lessor will cover the costs of all attorney fees for Utah Event Rentals.

d. CHILDREN'S SAFETY DEPENDS UPON YOU. YOUR PERSONAL SUPERVISION IS ABSOLUTELY REQUIRED. AS THE LESSEE OF THE UTAH EVENT RENTALS UNIT, THE SAFETY OF ALL RIDERS IS YOUR RESPONSIBILITY.

e. Absolutely no "Silly String", gum, candy, food, or other sticky substances are allowed in the UTAH EVENT RENTALS unit. If upon pick up, such cleaning is required then a minimum **\$50.00** or greater cleaning fee shall be automatically imposed. Additionally, if water is used on the bouncer, you will be charged a second day's rental at full price.

**DO NOT MOVE** the UTAH EVENT RENTALS unit from the place where it was installed. There may be an additional fee if the Unit is moved without consent from UTAH EVENT RENTALS. If the UTAH EVENT RENTALS unit moves, pull the corner back to its **original** location of installation.

**4. SPECIAL INSTRUCTIONS:** The UTAH EVENT RENTALS unit's equipment is reliable. Should the UTAH EVENT RENTALS unit begin to deflate: Proceed to the entrance of the jump and help the children exit from the jump. After everybody is out of the jump check the following: **1)** the motor may have stopped, in which case check the cord connection at the outlet. Do not use any more than a total of a 100 feet of heavy extension cord (Stronger outlets are in the kitchen and laundry room), **2)** if the motor is continuing to run, check the air intake on the side of the motor for blockage, and check both tubes at the back of the UTAH EVENT RENTALS unit for snugness: re-tie if necessary, or **3) If you can not correct the problem call UTAH EVENT RENTALS @ (801) 793-7833 or (801) 808-0565**

**5. SAFE OPERATION ACKNOWLEDGMENT:**

LESSEE ACKNOWLEDGES THAT HE/SHE HAS BEEN INSTRUCTED ABOUT AND FULLY UNDERSTANDS THE SAFE OPERATION OF THE UTAH EVENT RENTALS UNIT THAT IS THE SUBJECT OF THIS RENTAL AGREEMENT. LESSEE AGREES TO OBSERVE ALL SAFETY PRECAUTIONS. LESSEE ALSO REPRESENTS AND WARRANTS THE SAFE RETURN OF THE UNIT AND HEREBY AGREES TO PAY TWO THOUSAND-FIVE HUNDRED (\$2,500) IF IT IS NOT RETURNED. THERE IS A MINIMUM CHARGE OF \$100 FOR EACH REPAIR/HOLE TO THE UNIT DUE TO THE LESSEES NEGLIGENCES. A CHARGE OF \$50.00 PER HOUR PLUS MATERIAL WILL BE IMPOSED.

**6. MAINTENANCE:**

Lessee agrees to keep the UTAH EVENT RENTALS unit in the SAME condition as when received, ordinary wear accepted.

**7. ALTERATIONS AND ATTACHMENTS:**

No alteration in or attachments to the UTAH EVENT RENTALS unit will be made without prior written approval of Lessor.

**8. WARRANTY:**

Lessor warrants that the UTAH EVENT RENTALS unit leased under this Rental Agreement will be in good working order on the effective date of the Rental Agreement. The UTAH EVENT RENTALS unit is supplied and maintained subject to this warranty. Lessor's obligation under this Rental Agreement is limited to repair or replacement of the UTAH EVENT RENTALS unit when Lessor determines that it does not conform to this warranty. This warranty is in lieu of any and all other warranties expressed or implied, and of any and all obligations and of all liabilities on the part of the Lessor for damages, including, but not limited to. Consequential damages, arising out of or in connection with the use or performance of the UTAH EVENT RENTALS unit.

**9. TITLE TO JUMP:**

Lessee agrees to keep the UTAH EVENT RENTALS unit in his/her custody and not to sublease, rent, sell, remove from the Delivery Address, or otherwise transfer such UTAH EVENT RENTALS unit. The UTAH EVENT RENTALS unit will remain the property of the Lessor and may be removed by Lessor at any time after the termination of this Rental Agreement.

**10. RELEASE OF LIABILITY:**

The Lessee shall be in charge of the UTAH EVENT RENTALS unit's operation and any other rental equipment, and is fully responsible for its operation as well as return of all equipment including the UTAH EVENT RENTALS unit and all other rental equipment in good working order. Lessor and its officers, employees and agents is / are not responsible for injury occurring to the Lessee or to any other persons using the UTAH EVENT RENTALS unit, generators or any other rental equipment and the Lessee further agrees to hold the Lessor and its officers, employees and agents free and harmless against any injury or claims. The Lessee shall indemnify the Lessor and its officers, employees and agents from / against any costs incurred due to claims from anyone and for attorney's fees and related costs involving the use and return of the UTAH EVENT RENTALS unit or any other rental equipment (including but not limited to: generators, tables and chairs) should legal action become necessary.

**11. ENTIRE AGREEMENT:**

The Rental Agreement constitutes the full agreement between Lessor and Lessee. Time is of the essence in this Rental Agreement. The receipt of the UTAH EVENT RENTALS unit that is the subject of this Rental Agreement is in good working order and repair and this is so acknowledged by Lessee.

**12. WEATHER POLICY:**

**DURING PERIODS OF SEVERE WEATHER CONDITIONS (I.E. RAIN, HIGH WINDS, ETC.), WE RESERVE THE RIGHT TO CANCEL YOUR RESERVATIONS. IF CONDITIONS ARE NOT TOO SEVERE WE WILL GIVE YOU THE OPTION OF KEEPING IT OR NOT. IF YOU DECIDE TO KEEP THE UNIT FOR THE TERM OF THIS RENTAL AGREEMENT, THERE WILL BE NO REFUNDS!**

**13. Bounce House Blowers :**

Never service unit when plugged into electrical outlet. Make sure unit is grounded. Plug unit into a grounded receptacle only! Be sure that the switch is in the "OFF" position before plugging unit in.

**WARNING!** -- Never leave unit running unattended. **DO NOT ALLOW CHILDREN TO OPERATE UNIT!** Lessee has acknowledged that he or she has been fully instructed as to the operation and safety procedures of rental equipment. Never touch Hot or moving parts. Never fill generator with gasoline when engine is hot! Never operate rental equipment in a wet environment. Never operate under the influence of alcohol or impairing substances.

**CANCELLATION POLICY:** You must cancel your appointment a week prior to set up time for no fee. If the lessee fails to cancel, they will be charged the complete fee for showing up. If the bouncer is dropped off and weather is bad you will be charged a complete fee and may or may not be able to reschedule, depending on availability, there will be a \$50 transfer fee. If you cancel prior to the delivery date due to the weather, you may either reschedule to an available date or pay a \$50 cancellation fee.

#### 14. Condition of the Item(s)

External appearance, condition of components, operation of the Item(s) as well as any following guarantees given between the parties (list any visible damage or wear):

In the event that guarantees that are provided, turn out to be inaccurate, the Lessor forfeits the right to invoke those clauses relating to damage that the Lessee has caused to the Item rented, unless the damage in question has no direct link to the inaccuracy of the Lessor's statements.

#### 16. Security Deposit

At the start of the rental period, the Lessee agrees to pay the Lessor a security deposit of \$500 Cash per Unit or the Lessee will supply a valid Credit Card for any incidentals incurred during the rental period.

This deposit guarantee will be reimbursed in full upon return of the Item to the Lessor, deductions having been made for any consumable supplies that were used – as determined by their usual prices listed above – and deductions made.

#### 17. Maintenance, Damage and Theft

1. The Lessee will use, maintain and take care of the Item in a careful and responsible manner.
2. The Lessee will be held liable for any damages he/she causes to the rented Item. His/her liability will not exceed the potential residual value of the Item, as defined in good faith or contractually.
3. In the event that the Lessee returns the Item in a bad and/or poorly maintained condition (which cannot be described as the result normal rental use), requiring special cleaning or attention, the Lessee will be liable to pay the cost of cleaning (**\$50.00**) or potential maintenance carried out by a professional specialist. This service provider will be chosen by the Lessee within a period of 10 working days, or, if need be, after formal notice is given by the Lessor.

#### 18. Liability

The Lessee states that he/she has, and is presumed to have, all the information and skills necessary for careful and normal use of the rented Item(s); it is his/her responsibility to supplement his/her knowledge if necessary.

Similarly, he/she states that he/she has the authorization, licenses and legal capacity to have or use the Item(s).

The Lessee is the sole custodian of the Item(s) during the Rental Contract; he/she undertakes as such to exercise effective and exclusive control of the Item(s).

The Lessee is therefore the sole person responsible, apart from the Lessor, for any damage that the Item(s) could cause to the Lessee or a third party. The Lessee expressly recognizes that he/she is the custodian of the Item(s) rented for the full duration of the contract and, should the case arise, beyond this time, until the return of the Item(s) to the Lessor is accomplished

Consequently, the Lessor assumes no liability during the rental period for the Item(s) rented, in particular regarding its incorrect, imprudent or illegal use.
